Grant Application & Guidelines

TCT Federal Credit Union is dedicated to strengthening our community through financial services and education. The TCT Supports the Trades Grant aims to empower our members by providing funds for educational expenses, including; tuition, books, supplies, tools, uniforms, and boots, or to assist in acquiring the necessary equipment for starting a new job in a trade.

AM I ELIGIBLE?

The applicant must be a member in good standing of TCT Federal Credit Union who is 16 or older and has enrolled in or completed the following programs to enter the workforce: GED, Adult Continuing Education, Career and Technical Education (CTE), or Trade Certification.



Application Process

To apply, eligible members must complete the grant application form. The application must be accompanied by the following supporting documents: a program Acceptance Letter or Certificate of Completion and documentation that supports the cost of the request.

Our preferred method for applying is through our online application system. This platform streamlines the submission process, allowing you to efficiently enter your information and attach necessary documents. The funds awarded will be directly deposited into the recipients' TCT FCU share account.

Selection Process: The acting committee members will review requests within 30 days of receiving a complete application. Awards will be granted on a first-come, first-served basis until the annual budgeted amount has been exhausted. There is a lifetime cap of \$1,000 per applicant.

This application will not be considered unless all information is completed in full, on this form only, and all requested documentation is provided.

Awarded recipients will be notified via email.
